1.	M/S Shri S M Autade Pvt. Ltd	-Surety Bond expiry date 16/05/2026 -Only 4 ITR submitted , Last 5 years required
2.	T & T Infra Limited	-Surety Bond expiry date 16/05/2026 (Min. required 29/06/2026)
3.	L C Infra Projects Pvt. Ltd.	-The bidder does not meet the requirement as per the clause 4.2(a). The bidder submitted total 3 contracts including STP works which is not relevant component. Also, bidder has not provided breakup for STP work.



SI No	Bidder	Reason for Bid Rejection
4.	M/S Sonai Infrastructure Private Limited	-The bidder does not meet the requirement as per the clause 4.2(a). No specific construction experience as required. Bidder has submitted 3 contracts, of which one does not include the required similar works, while another contract is not certified by the Engineer-in-charge. For the third contract, the work experience is relevant, however the value of work is less than INR 3000 million required for single contract.
5.	M/S N D Waddar & Co.	-The bidder does not meet the requirement under Clause 4.2(b). The bidder does not satisfy the minimum requirement of 12,000 cum of concrete above M20 grade. Since the submission includes only M20 grade and no quantity above M20 grade, the bidder fails to comply with this criterion.
6.	M/S JSP Projects Pvt. Ltd.	- The bidder does not meet the requirement as per the clause 4.1 (a). For clause 4.1 (a), General construction experience submitted for only one project against requirement of at least 3 projects in the last 7 years.
7.	SRC Infra Developers	-Solvency certificate not submitted -Only 4 ITR submitted (Last 5 year Required)
8.	Sri Avantika Contractors (I) Limited	-Solvency certificate not submitted
9.	SMS Limited	-Solvency certificate not submitted
10.	SRM Contractors	-Solvency certificate not submitted

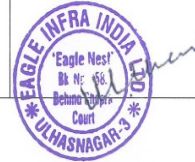
